There are opportunities within the Live Oak property to reduce fuel loads that carry wildfire and to reduce weed populations in the non-native and in the native vegetation communities. The Live Oak Grazing Feasibility study outlines an approach and preliminary plan to use conservation grazing as a management tool for the property. The study proposes to implement intense, short-duration cattle grazing 1 to 2 times per year to remove annual weeds while leaving time for growth and seed set of native perennials, timed in late winter and a second event in spring.
